# Resolution Authorizing the Solicitation of Proposals for an Access Control System, RFP P49262

### **Purpose**

To fully replace MARTA's access control system which includes the design, installation, configuration, and testing of all hardware and software components required to control and restrict door and gate physical access. These facilities include existing Access Control locations, as well as proposed facilities based on expansion and/or security needs.

#### **Benefits**

Upon completion, most of MARTA's facilities with electronically controlled doors and gates will be managed by a single access control system. This includes mechanical doors and gates which require badge reader access to enter and/or exit a restricted work area.

#### **Procurement Considerations**

Following approval by the Board of Directors to advance this Request for Proposals, staff intends to seek proposals from the marketplace. These proposals will be evaluated by staff based upon clearly defined criteria and vendor responsiveness of the proposals.

#### **Financial Considerations**

Technology is seeking a three (3) year contract term with two (2) 1 year options for renewal.

Upon approval procurement will be funded using a combination of Local Capital and Operating funds for FY25 – FY27, FY28, FY29 budget years.

## PROCUREMENT OF AN ACCESS CONTROL SYSTEM, RFP P49262

WHEREAS, the Authority is authorized by Section 14(m) of the MARTA Act to procure goods and services without competitive bidding if it is impracticable to prepare adequate specifications and an adequate description on the basis of which to solicit competitive bids; and

WHEREAS, the General Manager/CEO has certified, in accordance with Section 14(m) of the MARTA Act, that the procurement of an Access Control System is impracticable through the solicitation of competitive bids; and

WHEREAS, award of a Contract for the procurement of an Access Control System, after the solicitation of proposals and selection of a preferred proponent pursuant to Section 14(m) of the MARTA Act, is subject to approval by the Board of Directors.

RESOLVED THEREFORE, by the Board of Directors of the Metropolitan Atlanta Rapid Transit Authority that the General Manager/CEO, or his designee be, and hereby is, authorized to solicit proposals for the procurement of an Access Control System by means other than competitive bidding, in accordance with Section 14(m) of the MARTA Act, through the use of Request for Proposals.
